BEQUESTS



What is a bequest?

A bequest is a gift you make through your Will. Your gift can be many things: cash, property, securities, etc.

How does a bequest work?

In your Will, you usually list what you'd like to leave behind, and to whom. You can choose to leave BCB a specific amount of money, or a percentage of the value of your total possessions.

Making a bequest can be as simple as inserting a paragraph into your Will.

A gift in your Will is a simple, thoughtful way to support bowls in Canada.

TYPES OF BEQUESTS

THERE ARE DIFFERENT WAYS YOU CAN LEAVE A GIFT

Specific bequest

You wish to leave a gift for a specific amount to BCB.

Suggested wording: "I give to Bowls Canada Boulingrin the sum of (state dollar amount)."

Residual bequest

You wish to leave a portion of your estate to BCB after all debts and specific bequests are paid.

Suggested wording: "I give to Bowls Canada Boulingrin all (or stated percentage) of the rest, residue and remainder of my estate."

Contingent bequest

You wish to leave some or all of your estate to BCB only if other beneficiaries in your Will pass away before you do.

Suggested wording: "If (indicate beneficiary name) does not survive me, then I give all the rest, residue and remainder of my estate to Bowls Canada Boulingrin."
